The initial registration fee is £15 (or £10 concessionary rate for those aged 65 or over, or full time students). This fee covers membership up to 31 August. Membership renewal then becomes due at the reduced rate of £12 (concessions £8) if paid by standing order on or before the date of the September concert. If paid before that date but by other means, or if paid after that date, the rate is £15 (concessions £10).

On joining you will be given a copy of the KDCMS directory. You will be welcome to contact any of the members listed and to attend any of the advertised concerts. Notices of events and concert programmes will be sent to you monthly by email about ten days in advance of a concert. Please read the information overleaf relating to the General Data Protection Regulation. Note relating to the General Data Protection Regulation which came into force in the UK on 25 May 2018. As a consequence of this Regulation, KDCMS needs to ensure that members have given their consent to the use of their personal data (i.e. their names, postal and email addresses, and phone numbers) before publishing the data in the notices and Directory.
